 Duly accomplished Report of Birth Form (4 originals)

Bring original and 4 photocopies of the following:

- 1. Australian issued Birth Certificate
- 2. Passports of parents
- 3. Parent/s proof of status i.e., Visa issued by Australia, Dual Citizenship documents
- 4. Philippine Statistics Authority (PSA) issued Marriage Certificate of Parents (if married) or Report of Marriage of Parents (if married overseas)
- 5. If Parents are not married and the child will use the surname of the Father, the following are required:
 - a. Father shall execute an Affidavit of Admission of Paternity (AAP)
 - Mother/Guardian shall execute an Affidavit to Use the Surname of the Father (AUSF)
 - i. If child is 0-6 y/o; AUSF to be executed by mother
 - ii. If child is 7-17 y/o: AUSF to be signed by the child with Sworn Attestation of Mother/Guardian
 - iii. If child is 18 y/o above; AUSF to be executed by child with no required Sworn Attestation
- 6. Fee: AUDS45

*Please note that each Affidavit has an additional fee of AUD\$45

For Delayed Registration (1 year after the date of birth): submit Affidavit of Delayed Registration of Birth
